# **FOIC 2025 Conference Code of Conduct**

This *Code of Conduct* outlines the expected behavior and guidelines to foster a positive and professional experience for everyone involved.

# **Expected Behaviour**

- 1. **Respect and Inclusivity**: Treat all participants—including attendees, speakers, organizers, sponsors, exhibitors, and volunteers—with courtesy and respect. Embrace the diversity of perspectives, experiences, and cultural backgrounds.
- 2. **Professional Conduct**: Maintain a professional demeanor in speech, actions, and attire. Engage respectfully in discussions, avoiding offensive or disruptive behavior.
- Constructive Engagement: Participate actively and constructively in sessions, workshops, and networking events. Share thoughtful and helpful feedback to encourage meaningful dialogue.
- 4. **Personal Boundaries**: Be considerate of others' personal space and boundaries. Avoid any form of unwelcome attention or behavior.
- 5. **Environmental Responsibility**: Follow green practices to align with the conference theme of sustainable innovations. Dispose of waste responsibly and minimize resource consumption wherever possible.

## Unacceptable Behaviour

- 1. **Harassment**: Harassment of any kind—including verbal, physical, or psychological—is strictly prohibited. Examples include offensive comments, discriminatory jokes, inappropriate gestures, or unwanted advances.
- 2. **Discrimination**: Discrimination based on race, gender, gender identity, sexual orientation, disability, religion, or any other personal characteristic is not acceptable.
- 3. **Intimidation and Threats**: Intimidating or threatening behavior that creates an unsafe or unwelcoming atmosphere will not be tolerated.
- 4. **Substance Abuse**: Impairment due to excessive alcohol consumption or illegal drug use is prohibited.
- 5. **Session Disruptions**: Avoid disruptive behavior such as inappropriate use of mobile devices, loud talking, or any action that interrupts the flow of presentations or discussions.
- 6. **Unwelcome Solicitation**: Promotion of products, services, or causes outside designated exhibit spaces or networking sessions is not permitted.

#### **Consequences of Misconduct**

Violations of this *Code of Conduct* will be addressed promptly. Consequences may include:

- 1. Warnings: A verbal or written warning issued by conference organizers.
- 2. **Expulsion**: Removal from the event without a refund for serious or repeated violations.
- 3. **Further Action**: In cases of severe misconduct, the incident may be reported to relevant authorities for appropriate action.
